#### **1. Public Session**

No issues were raised under this item.

#### **2. Absence**

Apologies for absence were submitted on behalf of Councillors R Curnow, Mrs C Rule and C Rule.

#### **3. Minutes**

The minutes of the Parish Council Meeting held on Tuesday 15 June 2010 were proposed by Councillor Mrs S Ireland, seconded by Councillor P Wilkins, unanimously approved and then signed off by the Chairman as a true record.

#### **4. Declarations of Interest**

No declarations of interest were received.

#### **5. Planning**

Following consideration by the Councillors of the Planning Applications received from Cornwall Council, the following decisions were made for recommendation to Cornwall Council.

PA09/01427/LBC – Mr I Stanley – Parc Venton House, Garro Lane – Erection of garden room extension and installation of external door to dwelling – amended plans

Following a discussion, Councillors made the following observations:-

- The amended plans were not significantly different to the original plans submitted in November; and
- The observations made by English Heritage and the Parish Council following consultation on the original plans had not been taken into consideration, and the Parish Council's previous objections still applied.

It was proposed by Councillor P Wilkins to support the application. This proposal was not supported.

It was then proposed by Councillor Mrs S Ireland, seconded by Councillor R Willey and agreed to object to the application on the above grounds, on a vote of three to one.

The Clerk was requested to suggest to Cornwall Council that English Heritage be re-consulted on the amended plans.
